We may modify these provisions at any time. Any such modifications are effective immediately from the time they are published on our website. You agree to review these provisions regularly to ensure you become aware of any modifications to them.

We do not accept any liability loss or damage which you may incur as a result of any content or information contained in or collected from any third-party websites.

# Who is responsible for your data?

JG Pears Holdings (Jersey) Limited ("JGP") has overall responsibility for your data.

# What personal information do we collect?

We may collect information in the following ways:

- when you contact us by telephone, by e-mail, or on this website;
- when you register on our website to use our services; and
- by way of cookies, such as details of your visits to this website and resources you access.

For further information on the purposes for which we use cookies and on our storage of and, access to, information collected by such cookies, please see our Cookie Policy.

# **Cookies**

Cookies are tiny text files stored on your computer when you visit certain web pages. We use cookies to keep track of any quotes you have saved or any services you have ordered and to remember you when you return to our site. To order a service at our website, you need to have all cookies enabled, though you can still use the website for browsing and research purposes without enabling them.

## Making an enquiry

If you make an enquiry with us, we will store your name, geographical address including postcode, email address and phone number(s), which we will use to communicate with you.

#### Requesting a call-back from us

If you request contact from us, we will store your name, geographical address including postcode, email address and phone number(s), which we will use to communicate with you.

## Requesting a Quotation

If you request a quotation, we will store your name, geographical address including postcode, email address and phone number(s), which we will use to communicate with you. We will also store information about your requirements and preferences regarding the services for which you are requesting a quotation.

# **Ordering Services**

If you order from us, we will store your name, geographical address including postcode, delivery address including postcode, email address and phone number(s) to contact you, if necessary, about your order, to deliver services that you have purchased and to inform you by email of the progress



of your order.

# **Job Applicants**

If you submit an application for employment to us, we will store all of the details on that CV or application, including personal details of your referees. By giving us your referees' data, you are representing to us that you have consent for us to hold their names and contact details. The data contained within your application for employment will only be held to process your application and any subsequent employment. Should you not be offered employment with JGP, your job application data will be destroyed unless you give us express consent to hold it on file for consideration for positions arising in future.

Where your job application contains sensitive personal data, such as your racial or ethnic origin or religious beliefs, by sending it to us you are giving us your consent to collect and process this sensitive personal data. We will only use such data during the course of your employment to monitor equality and diversity issues within the company. All other data held by JGP will be used only for matters relating to your status as an employee of the company. We will only disclose information to a third party where required by law to do so.

## **Data Protection**

We will comply with the requirements of all relevant data protection legislation in force from time to time. In particular, you may request a copy of any personal data held by us about you, upon written application. If you believe that any personal information we hold about you is incorrect or incomplete, please contact us immediately. Any information found to be incorrect will be corrected promptly. # For which purposes will we use your personal data?

- to pass on to a successor in title to our business or to anyone to whom we assign our contract with you.

- notify you about changes to our service.

# For how long will we retain data?

Data will be deleted when it is no longer reasonably required for the Permitted Purposes or you withdraw your consent (where applicable) and where we are not legally required or otherwise permitted to continue storing such data.
